
Step 1.

Have the Green Visor and the Clear APET Sheet at the ready.



Step 2.

- a) Attach the left hole on the clear APET sheet into the left bracket point, with the green visor facing you.
- b) Attach the 2^{nd} hole on the clear APET sheet into the 2^{nd} bracket point on the green visor.
- c) Attach the 3rd hole on the clear APET sheet into the 3rd bracket point on the green visor.
- d) Attach the 4th hole (only hole with a small slit on the right side, this is to ensure the hole can fit into the bracket point with ease) into the 4th and last brocket point with slight pressure.



Step 3.

To fix the head strap to suit your preferred size, insert the tie through the small hole on the green visor. The size can be adjusted with the 18 size clips to suit the preferred fitting. To re adjust the size, you can feed the tie back through the hole.



Step 4.

The visor can then be placed onto the head and secured in a comfortable position for your personal protection.
